EFFECTIVE IN: All territory served.

AVAILABILITY: Alternating current for use other than in a residential dwelling unit. Service will be rendered at one location at one voltage.

No resale, breakdown, auxiliary or supplementary service permitted. Where commercial and residential service area served through one meter, this General Service Rate shall apply to the entire load.

The application of this rate schedule is limited to customers with annual kWh consumed of less than 140,000 kWh or the Maximum Demand during the 12 months ending with the current month was less than 30 kW. The Company shall install metering equipment that measures monthly Maximum Demands, if, in its sole judgment, such equipment is necessary to determine whether the above condition has been met.

DEFINITION OF SEASONS:

Summer Season: The five OG&E Revenue Months of June through October.

Winter Season: The seven OG&E Revenue Months of November through May.

DETERMINATION OF MAXIMUM DEMAND: The consumer's maximum demand shall be the maximum rate at which energy is used for any period of 15 consecutive minutes of the month for which the bill is rendered as shown by the Company's demand meter.

MINIMUM BILL: The minimum monthly bill shall be the Customer Charge.

RIDERS: Applicable Riders which adjust this Rate Schedule are listed in Rate Schedule No. RSR, Tables of Riders Applicable to Rate Schedules.

TERM: Open order. The Company may require a contract for a year or longer, subject also to special minimum guarantees, which may be necessary in cases warranted by special circumstances or unusually large investments by the Company. Such special minimum guarantees shall be calculated in accordance with the Company's Allowable Expenditure Formula in its Terms and Conditions of Service filed with and approved by the Commission.

Customers qualifying for the General Service rate shall remain on that rate for at least one year unless demonstrating a permanent change in electric consumption, notifying the Company of such change and requesting transfer to another applicable tariff.
