**GENERAL SERVICE TIME-OF-USE WITH CPP**

**STATE OF OKLAHOMA**

**EFFECTIVE IN:** The Oklahoma Retail Jurisdiction.

**AVAILABILITY:** This Tariff is limited to customers currently taking service under General Service, General Service – Time-of-Use, Public Schools Non-Demand, Public Schools Non-Demand – Time-of-Use, Oil and Gas Producers Non-Demand, and Oil and Gas Producers Non-Demand – Time-of-Use tariffs. This tariff is an optional tariff and is available only to those customers for whom OG&E has installed the applicable technology equipment required for this tariff. Customers with the appropriate equipment will be notified of the availability of the rate. Initially, this tariff will be limited to the number of customers that the Company determines can be effectively administered under the constraints of Company’s capabilities.

The Company’s Rules, Regulations, and Conditions of Service and the Commission’s Rules and Regulations apply to service provided under this tariff. This tariff is not available for resale, stand-by, breakdown, or auxiliary service.

**TERM AND SERVICE TERMINATION:** The initial subscription term is for one year. After the initial subscription term, a customer will continue service under this tariff until another tariff is selected by giving 30 days notice to the Company. If the thirtieth day of the notice period does not fall on the last day of the billing month, service will continue under this tariff through the next billing period. If a customer terminates service under this tariff, the customer will not be eligible to receive service under this tariff for a period of twelve (12) revenue months from the termination date.

**PRICES:** The on-peak period kWh price and critical peak price contains 8.00¢ per kWh of embedded fuel cost and the off peak period and winter prices contain 2.60¢ per kWh of embedded fuel cost.

**ALL SERVICE LEVELS (Service Levels 2-5):**

**Customer Charge:** \$24.00 per bill per month.

**Energy Charge:**

**Summer Season:** On-Peak Hours kWh per month: 30.00¢ per kWh.

Off-Peak Hours kWh per month: 4.7¢ per kWh.

**Winter Season:** First 1,000 kWh per month: 9.00¢ per kWh.

All Additional kWh per month: 5.00¢ per kWh.

Critical Peak Period: All kWh: 60.0¢ per kWh.

DEFINITION OF SEASONS:

Summer Season: The five OG&E Revenue Months of June through October.

On-Peak Hours: From June 1 through September 30, beginning each day at 2:00 p.m. until 7:00 p.m. local time, excluding Saturdays, Sundays, Independence Day (as observed) and Labor Day.

Off-Peak Hours: All hours not defined as On-Peak hours.

Winter Season: The seven OG&E Revenue Months of November through May of the succeeding year.

Critical Peak Period: Any period designated by the Company, subject to the limitations set forth within the Critical Peak Price Overcall Provision of this tariff.

CRITICAL PEAK PRICE OVER-CALL PROVISION: The Company may, with at least two hours notice, designate a critical peak period, at any time during the year, for a period lasting not less than 2 hours and not more than 8 hours. The maximum number of hours during any calendar year that can be designated by the Company as critical peak period hours is 120. The price during the critical peak period will be the critical peak period price for all kWh consumed during the designated period. Communication of the over-call price will be provided by OG&E.

BEST BILL PROVISION: At the end of the initial subscription term the customer's GST-CPP billing will be compared to their otherwise applicable tariff billing using actual usage for the entire period. If the amount billed is higher than what the customer would have been billed under their otherwise applicable tariff the customer will receive a credit on their bill equal to the difference. The Best Bill Provision will only be applied after the first full year of subscription to the tariff and will not be available in the ensuing years.

The otherwise applicable tariff is defined as the tariff under which the customer was previously receiving service immediately prior to subscription in this tariff. In the case where a customer was not previously subscribed to another tariff, the otherwise applicable tariff shall be the GS tariff.

STANDARD PRICING SCHEDULE: GST-CPP  
GENERAL SERVICE TIME-OF-USE WITH CPP

**SERVICE LEVELS:** For purposes of this rate, the following shall apply:

**Service Level 2:** Shall mean service at any nominal standard voltage of the Company between 2 kV and 50 kV, both inclusive, where service is rendered through a Company Substation, which has a transmission voltage source, and the point of delivery is at the load side of the substation or from a circuit dedicated to the customer.

**Service Level 3:** Shall mean service at any nominal standard voltage of the Company between 2 kV and 50 kV, both inclusive, by a direct tap to the Company's prevailing distribution source from a circuit not dedicated to the customer.

**Service Level 4:** Shall mean service at any nominal standard voltage of the Company between 2 kV and 50 kV, both inclusive, where service is rendered through transformation from a Company prevailing distribution voltage source (2 kV to 50 kV) to a lower distribution voltage with metering at distribution voltage.

**Service Level 5:** Shall mean service at any nominal standard voltage of the Company less than 2,000 volts with metering at less than 2,000 volts.

**Metering Adjustment:**

If the Company chooses to install its metering equipment on the load side of the customer's transformers, the kWh billed shall be increased by the amount of the transformer losses calculated as follows:

**Service Level 3:** 0.60 percent of the total kVA rating of the customer's transformers times 730 hours.

**LATE PAYMENT CHARGE:** A late payment charge in an amount equal to 1.5 percent of the total balance for services and charges remaining unpaid on the due date stated on the bill shall be added to the amount due. The due date as stated on the bill shall be 20 days after the bill is issued.

**MINIMUM BILL:** The minimum monthly bill shall be the Customer Charge. The Company shall specify a larger minimum monthly bill, calculated in accordance with the Company's Allowable Expenditure Formula in its Terms and Conditions of Service on file with and approved by the Commission, when necessary to justify the investment required to provide service.
