#### Question #3

On the NOI form, please explain what is meant by ( $MW_{ac}$ ).

**A:**  $MW_{ac}$  is intended to indicate the amount of Deliverable Capacity from the resource to SPP. Please refer to the most recent SPP Deliverability Study Result that identifies the maximum available Deliverable Capacity.

#### Question #4

Are there circumstances where a bidder can pull, modify their offer? For example, if something occurs between the offer due date and November 30<sup>th</sup> causing the MWs from a resource to no longer be available or if a bid is selected but the parties cannot find agreement to credit or confirmation agreement terms.

**A:** Bidders may withdraw an offer at any time in the RFP process. For Bids not withdrawn, negotiation of agreement terms will occur in the period following selection of Bids. Section 2.3 and Appendix D of the RFP state that "Bids shall be considered as irrevocable and may not be modified, except as agreed upon in mutual negotiations between the Bidder and OG&E in the post evaluation period." Modification of Bids is addressed by the Oklahoma Corporation Commission's Competitive Procurement Rules in OAC 165:35-34-3 (d) (2), "No bidder shall be permitted to unilaterally submit a refreshed bid unless all bidders are given a meaningful opportunity to submit a refreshed bid as a result of some material, documented change." At this time, OG&E does not anticipate allowing modification of Bids in this RFP process.

#### **Question #5**

Do Bidders need to use the OG&E provided CPA Form Agreement [ISDA Schedule and Confirmation] or is it acceptable to refer to a different form of agreement and draft additional confirmation?

**A:** OG&E requests all Bidders to redline the provided ISDA Schedule and Confirmation Form CPA. OG&E will analyze all Bids as defined in Section 3 using the same Form CPA. Bidder(s) may use a different form of agreement with additional confirmation (if needed), provided that their Bid is selected as a winning Bid post OG&E's analysis.
