# DUCT & AIR SEALING REBATE RULES AND GUIDELINES

## REBATE DETAILS

- Rebate applies only to OG&E customers with an active residential account.
- Rebates are shown in chart below.

Measure	Leakage reduction	Rebate
Air Sealing	≥15%	\$100
	≥30%	\$150
Duct Sealing	≥25% - 50%	\$225
	>50% - 75%	\$275
	>75%	\$300

- Rebate will not exceed contractor invoice amount.
- Rebates are issued in the form of checks, not utility bill credits.
- Only one (1) rebate request per service address.
- Rebate Application and Invoice must be received within 30 days of completion of job.
- OG&E is not responsible for inaccurate information.
- Funding for this program is limited to funds availability.

## REBATE APPLICATION DETAILS

Qualifying duct and air sealing must have an invoice dated between January 1, 2018 and December 31, 2018. Completed rebate application and invoice must be submitted no later than 30 days after the insulation installation.

A valid invoice includes the installation date, services purchased, duct and air sealing, price and payment made in full. The duct and air sealing invoice must also specify all required information, including the customer name, address of installation, phone number, contractor name, business name, address and phone number. All information on the invoice must match the information on the rebate application or the application will not be processed. **Failure to complete all information will result in denial of rebate.**

## DO NOT INCLUDE REBATE APPLICATION WITH YOUR OG&E ELECTRIC BILL.

OG&E reserves the right to conduct random inspections to verify installation of the rebated services or equipment at the installation address listed on the form. **OG&E reserves the right to inspect installations before issuing a rebate. If the residence does not have the qualifying material or work installed, the homeowner may be required to pay back the rebate and the contractor will be deemed ineligible to offer rebates to future customers.** OG&E reserves the right to amend or suspend this program without notice.

## LIMITATIONS OF LIABILITY; INDEMNIFICATION

In no way shall Oklahoma Gas and Electric Company be liable for, and Customer hereby agrees to indemnify, defend and hold harmless Oklahoma Gas and Electric Company, its subsidiaries or affiliates, and their respective employees, Officers and directors, from and against any and all liability, loss, damage, cost or expense, including attorney's fees, that may be caused by, due to, occasioned by, or otherwise arising out of the installation, operation, mis-operation, or use of customer's installed materials and installations.

Oklahoma Gas and Electric Company is not responsible for any taxes that may be imposed as a result of your receipt of any rebate.

## QUALIFYING CUSTOMERS

- This program is available only to OG&E Arkansas customers who own or rent a permanent foundation single family home that was built prior to 2015.
- Multi-family structures qualify for this rebate, however participation must be approved by the program prior to installation.
- Program is available only to retro-fit (existing) homes built prior to 2015 with electric air conditioning.
- Program excludes new home residential construction, garages, sheds, workshops, basement and doors.

## QUALIFYING INSTALLATION

- An approved, Building Performance Institute (BPI) certified program contractor must complete duct and air sealing installation using proper diagnostic techniques and equipment, including Duct Blaster and Blower Door.
- Duct Sealing testing must be completed using the leakage to outside methodology.
- Existing duct leakage conditions must be greater than or equal to 80 CFM25, but less than 40% total fan flow (HVAC tonnage x 400 CFM).
- Duct leakage must be reduced by 25% or greater in order to qualify for a rebate.
- Existing home leakage cannot exceed the pre-retrofit infiltration cap shown in table below.

Pre-Retrofit Infiltration Cap (x sq ft)			
Shielding Type	1 Story	2 Story	3 Story
Well Shielded	11	8.8	7.7
Normal Shielding	9.1	7.3	6.4
Exposed Shielding	8.2	6.6	5.7

- Air sealing installations must comply with the prevailing Arkansas mechanical code, which establishes a minimum ventilation rate (MVR) as shown in chart below.

MVR Multiplier (x sq ft)			
Shielding Type	1 Story	2 Story	3 Story
Well Shielded	1.28	1.02	0.9
Normal Shielding	1.07	0.85	0.75
Exposed Shielding	0.96	0.77	0.67

- Air sealing leakage must be reduced by 15% or greater to qualify for a rebate.
