OGE's Commitment

Our commitment at OGE Energy Corp. and our wholly owned subsidiary, Oklahoma Gas and Electric Company, is to provide energy-related services in a balanced and environmentally responsible and compliant manner. We energize life by providing life-sustaining and life-enhancing products and services while honoring our commitment to strengthen our communities. We are committed to protecting and responsibly managing the natural resources essential for a cleaner environment and for preserving the quality of life in the communities we serve. This Environmental policy is approved by the Company's Corporate Policy and Governance Committee composed of company executives and senior management responsible for policy governance. The Company's environmental, biodiversity and water use and risk management responsibilities report to the VP of Operations who reports to the Company's CEO.

ENVIRONMENTAL MANAGEMENT

The company's policy and approach to environmental management focuses on integrating compliance, accountability, operational excellence, and environmental leadership. The purpose of this approach is to manage risk and minimize adverse environmental impact of our operations while setting expectations for sustainability. Specifically, we will:

Accountability

- Comply with environmental regulations including local, state, federal and tribal laws and regulations governing protection of the environment.
- Assess compliance by conducting comprehensive and targeted assessments across operations utilizing thorough audit protocols and tracking issues to closure.
- Monitor, track and regularly report regulatory environmental obligations and performance internally with oversight and governance by the internal compliance committee and the company's Board of Directors, including quarterly reporting of third-party environmental audits and inspections to a subcommittee of the Board.
- Develop and implement processes, procedures, and metrics to assess compliance, address and mitigate environmental risks and identify opportunities presented by environmental changes.
- Set expectations for contractors and suppliers to comply with applicable environmental regulations and demonstrate a commitment to environmental sustainability and stewardship as set forth in this Environmental Policy and the OG&E Supplier Code of Conduct.
- Provide training, tools and resources for employees to conduct work in an environmentally compliant and responsible manner and empower employees and contractors to promptly report any concerns or potential violations through designated OGE reporting channels.

Operational Excellence

- Conduct business in a manner that minimizes environmental impacts and supports environmental protection, emission, waste and release minimization, efficient resource management and sustainability.
- Implement internal standards and continuously measure, assess, control and, as appropriate, optimize performance to those standards in support of the environmental policy and the company's values and beliefs.
- Consider emerging issues, changing regulatory environment, technological advances and stakeholder expectations in our planning and operations.

- Assess issues and develop balanced solutions and controls to prevent recurrence and monitor the company's environmental performance; share lessons learned throughout the company in support of continuous improvement.
- Develop, mature and maintain a comprehensive environmental management system to achieve operational excellence related to environmental aspects of our business.
