

STANDARD PRICING SCHEDULE: IR273
INTERIM RATES PUD 201500273 RIDER

STATE OF OKLAHOMA

EFFECTIVE IN: All territory served.

DESCRIPTION: The purpose of this Interim Rates PUD 201500273 (IR) rider schedule is to credit to customers any refund to which this rider is subject as referenced below in the REFUND section.

APPLICABILITY: This interim rate adjustment is applicable to the Oklahoma retail rate classes as shown below. The annual revenue requirement refund for all non-lighting rate classes will be collected via a per kilowatt-hour (kWh) rate and shall be applied to all kWh sales except those exempted under specific tariffs or special contract provisions. The annual revenue requirement refund for all lighting rate schedules will be collected via a monthly per lighting fixture rate and shall be applied to all lighting fixtures except those exempted under specific tariffs or special contract provisions.

TERM: The IR rider refund factors will continue until September 30, 2017 to refund all revenue requirement dollars in accordance with the Final Order in Cause No. PUD 201500273. These factors may discontinue at an earlier date if all revenue requirement dollars have been refunded by the earlier date. If all revenue requirement dollars have not been refunded by September 30, 2017, these factors may continue past that date until all revenue requirement dollars have been refunded but will continue to no later than December 31, 2017.

REFUND: The Commission, in Cause No. PUD 201500273, determined that a refund was appropriate and necessary. The refund is associated with the Interim Rates PUD 201500273 Rider revenue collected during the interim period of July 1, 2016 and the effective date of this tariff. The Commission ordered that the refund include reasonable interest at the one year U.S. Treasury bill rate accruing on that portion of the rate increase to be refunded for a period not to exceed ninety (90) days from the effective date of the rate increase which is being refunded. The factors will be updated to reflect any refund amounts owed to customers who left the system during the interim period and for any miscellaneous fee refunds.
